Dear Association Advocates:

Welcome to American Associations Day 2023! We are so happy to host you in Washington, DC, as we promote associations on Capitol Hill. American Associations Day is designed to inform legislators and Congressional staff about the Power of Associations—how our community contributes in direct and significant ways to economic development and societal advancement.

Thank you for spending time with ASAE and your peer-leaders in our community. We are grateful that you're bringing your unique experience and perspective to help build up associations in Congress, which will go a long way toward helping to build up the industries and professions we support.

Our collective voice makes a difference. Look no further than associations' steadfast advocacy to expand the Paycheck Protection Program (PPP) for thousands of associations, which helped protect many more thousands of jobs and reinforce our community's role to support American economy and society. Margarita Valdez Martínez is the Director of Policy and Advocacy for the American Society of Gene and Cell Therapy (ASGCT), the primary professional membership organization for gene and cell therapy. Through her work at ASGCT, Margarita seeks to advance the Society's priorities in policy development amongst legislators, providers, patient advocates, coalitions, and other stakeholders. With over 20 years of experience, she has a demonstrated history of success in health policy.

Prior to joining ASGCT, Valdez Martínez was the senior lobbyist for the American Society for Radiation Oncology (ASTRO). In that role, she developed, strategized, and advocated for the physician and professional member's policy priorities. Her efforts helped lead to payment stability for the membership through legislative and regulatory wins. She has also worked extensively with patient advocates; most notably during her tenure at the National Breast Cancer Coalition where she successfully advanced legislative strategies by leveraging a broad volunteer base which resulted in securing \$120M for the Department of Defense's Breast Cancer Research Program. And prior to that, while working at the American Health Information Management Association, Margarita helped launch a broad-based coalition to secure implementation of the10th revision of the International Statistical Classification of Diseases.

Valdez Martínez earned her undergraduate degree at Michigan State University, she currently serves as the Chair of Public Policy for the American Society of Association Executives, serves on the pastoral council for the Cathedral of St. Matthew the Apostle, and is a board member for the HER Foundation which supports women and families experiencing hyperemesis gravidarum. She currently lives in Washington, DC, with her husband, Miguel.



# Mark Dorsey, MBA, FASAE, CAE

### Chair, ASAE Power of Associations Oversight Committee Chief Executive Officer, Construction Specifications Institute

Before entering the association profession, Anderson was a candidate for the U.S. House of Representatives for the 16th Congressional District of Illinois. Anderson is currently the Immediate Past Chair of the Board of Directors of the American Society of Association Executives.

Brock joined AF&PA in 2019, establishing a strategic vision for the organization that has strengthened AF&PA's advocacy mission and increased membership. Brock guided AF&PA throughout the COVID-19 pandemic with a steadfast focus on workplace safety and ensuring manufacturers can continue to deliver essential products. Under Brock's leadership, AF&PA launched an award-winning website and earned two ASAE Silver Awards for communications efforts. In 2022, Brock was named one of Washington's 500 Most Influential People by Washingtonian Magazine.


## Sheri Sesay-Tuffour, PhD, CAE, ICE-CCP

## Freedom To Invest In Tomorrow's Workforce Act - H.R. 1477 / S. 722

Our "ask" is for each Member and Senator we meet with to join the legislation as a "cosponsor."

- The Freedom to Invest in Tomorrow's Workforce Act is bipartisan and bicameral.
- It would expand eligible uses of 529 education savings plans to include economy-building certifications and other post-secondary credentials.
- House of Representatives leads for H.R. 1477 are Representatives Rob Wittman (R-VA) and Abigail Spanberger (D-VA). There are no additional cosponsors for H.R. 1477.
- Senate leads for S. 722 are Senators Amy Klobuchar (D-MN) and Mike Braun (R-IN). Cosponsors for S. 722 are Senators Tammy Duckworth (D-IL), Susan Collins (R-ME), Dianne Feinstein (D-CA), Joe Manchin (D-WV), Martin Heinrich (D-NM), Peter Welch (D-VT) and Tommy Tuberville (R-AL).

### **General Talking Points**

- Associations nationwide pay approximately \$20 billion in wages
- As a community, associations are the largest provider of post-college education and skills training.
- Certifications provide pathways to opportunity and career growth across sectors—from entry-level jobs to mid-career certifications that help workers advance, to certifications that demonstrate highly specialized knowledge, skills and experience.
- The Freedom to Invest in Tomorrow's Workforce Act would provide Americans access to more and more affordable career pathways, no matter their educational background, skill level or age. The bill opens up tax-favored 529 plans for use by more Americans and those at all income levels.
- Expanding eligible uses for 529 plans would benefit all industries and professions that rely on employees with specialized training or recognized credentials.
- Certification reduces the racial wage gap among men by 43% and the gender wage gap between women and white men by 36-40%, according to the University of Chicago.
- The legislation would also help displaced workers, professionals seeking to transition careers, veterans, military spouses, caregivers reentering the workforce and those just beginning a career.

# **Meeting Process & Tips**

- Before meetings practice your introduction and elevator pitch; practice explaining the legislation. Determine who will begin and end each meeting and who will take notes.
- Open meetings with thanks to staffer(s) for taking the time to meet.
- Provide a brief introduction of yourself, ASAE's event, your organization and stakeholder community.
- Introduce the "ask" "We urge your boss to cosponsor the Freedom to Invest in Tomorrow's Workforce Act and appreciate any consideration to join the bill."
- Explain the legislation, how it would benefit the workforce and the value of certification and skills training. Tie to your organization's sector, if possible.
- Restate the "ask" and share the leave-behinds (i.e., legislation document and community sign-on letter).
- Thanks staffer(s) again for their time and close the meeting.
- Connect with ASAE staff, provide urgent meeting updates and complete the post-meeting online form.

# Support for the Freedom to Invest in Tomorrow's Workforce Act

**The bipartisan, bicameral Freedom to Invest in Tomorrow's Workforce Act (S. 722 / H.R. 1477)** would expand eligible uses of tax-favorable 529 savings plans ("529") to cover costs associated with workforce training and credentialing programs, such as professional certifications. This bill would provide valuable tax-advantaged resources for workers who pursue alternative career pathways, mid-career changes or career growth.

Expanding eligible uses for 529 plans would empower workers of any educational background, skill level or age and would benefit all industries and professions that rely on employees with specialized training or recognized credentials.

### What are 529 Savings Plans?

529 plans are state-sponsored savings vehicles for higher education that are exempt from federal taxes if funds are used to pay for qualified education expenses, which include: college, graduate or professional degrees; career and technical education programs from Title IV accredited institutions; registered apprenticeship programs; and up to \$10,000/year in elementary or high school tuition and certain student loan repayments.

### Training, Certifications and Other Credentials are Ineligible Under 529 Plans

The American workforce is comprised mostly of middle-skill jobs that require more than a high school education but not a bachelor's degree, according to the National Skills Coalition. A differentiator for obtaining jobs in the 21st century economy is professional certification—for workers with or without a college degree.

### Certifications Promote Economic Opportunity and a Resilient Workforce

Professional certifications provide pathways to opportunity and career growth across economic sectors—from entry level jobs to mid-career certifications that help people advance, to certifications that demonstrate highly specialized knowledge and skills. Certification reduces the racial wage gap among men by 43% and the gender wage gap between women and white men by 36%-40%, according to a University of Chicago report.

### Associations Conduct Events that Produce Significant Economic Activity

Major events, such as conferences, conventions and trade shows, fuel the hospitality sector and help provide associations the means to pay staff, promote stakeholders, lead communities, administer technical education and invest in essential tools and resources.

The following data demonstrate a small portion of events' broad economic impact:

- The events industry generates \$330 billion each year in the U.S.<sup>7</sup>
- At least one-fifth of associations conduct 50 or more revenue-generating events each year<sup>8</sup>.
- Associations dedicate 35 percent of their budgets to conducting events, on average<sup>9</sup>.
- The hospitality sector employs almost 16 million workers<sup>10</sup>.
- Individual association events contribute tens—often hundreds—of millions of dollars to state and local economies. (*The American Society of Association Executives (ASAE) four-day Annual Meeting hosts 5,000 professionals and injects \$16 million into local economies, on average; ASAE's 2018 Annual Meeting in Chicago, IL delivered \$150 million in downstream economic activity nine months after the event<sup>11</sup>.)*

### Associations Set Product, Service and Safety Standards

Product, service and safety standards protect and empower consumers, and associations establish critical standards for everything from children's toys to building construction—from mattresses we sleep on to food we eat. Standard-setting in the U.S. is a process historically driven by the private sector, with the government in a supporting and guiding role.

### Associations Provide Essential Technical and Subject-Matter Expertise

Associations help ensure their industries and professions carry a collective voice and that all stakeholders understand the complex issues and dynamic communities with which they interact. Associations are repositories of industry- and profession-specific expertise and serve as a resource to anyone who wishes to build knowledge.


