

# **Urgent: The Threat to Tax-Exempt Organizations**

#### **Executive Summary Overview**

As Congress prepares to debate the expiration of the 2017 Tax Cuts and Jobs Act (TCJA) next year, the tax-exempt sector faces a significant threat. Major think tanks have called for taxing 501(c) organizations, and with a \$4.6 trillion tax cliff looming, lawmakers are increasingly scrutinizing the sector as a potential source of revenue.

To combat this threat, ASAE is forming a coalition of tax-exempt organizations to take an aggressive stand against all proposals that would burden 501(c) organizations with increased taxation. ASAE is positioned to invest \$1M in strategic advocacy and communications counsel. We are seeking additional contributions from coalition members to support our advocacy efforts.

#### The Threat

- Increased Scrutiny: Lawmakers are questioning the value of tax-exempt status and considering whether organizations should pay more in taxes.
- Revenue Proposals: Think tanks have proposed taxing all non-donation income and eliminating tax-exempt status. This includes membership fees, investment income, trade show income, and fees for service.
- Lack of Understanding: Many lawmakers are unfamiliar with the scope and impact of the tax-exempt sector and need additional education on its economic value to the U.S. economy.

#### **The Need for Action**

- Coordinated Effort: A united front is essential to protect the ASAE's 50,000 association executives and their organizations that represent trade associations, professional societies, and industry partners from harmful legislation that constitute the tax-exempt sector.
- Education and Advocacy: We must have an ongoing and strategic campaign to further educate lawmakers about the benefits of the sector and advocate for policies that support its mission.
