

# Tomorrow's Workforce Coalition: In-District Advocacy Toolkit

The Tomorrow's Workforce Coalition and its member organizations are committed to advocating for beneficial workforce development policy that would strengthen the economy now and into the future. Specifically, the Coalition supports the bipartisan, bicameral *Freedom to Invest in Tomorrow's Workforce Act* (H.R. 1151/S. 756), which would expand qualified expenses under 529 savings plans to include post-secondary training and credentialing, such as licenses and nongovernmental certifications; it would provide valuable tax-advantaged resources to more workers pursuing career growth, mid-career changes or alternative career pathways.

The Tomorrow's Workforce Coalition has been relentlessly pushing for the passage of the Freedom to Invest in Tomorrow's Workforce Act through direct lobbying, grassroots campaigns, and various other advocacy tactics, but indistrict advocacy is an incredibly effective method to educate Congress on the importance of this legislation. The upcoming August Congressional recess is the most opportune time to meet with elected officials in-district and ensure they understand the importance of our supported legislation.

#### **Planning a Site Visit**

Interested in hosting your Member of Congress for a visit at your organization's headquarters, a member company's facilities, etc.? Sign up here, and TWC staff will follow-up with you to help facilitate. Here's how to make it count:

- Plan ahead: Coordinate with your targeted Congressional
  office early. It is often a good idea to display a "Welcome"
  sign in a high-visibility area to greet the official. It is
  also recommended to create an agenda and prepare
  any relevant data that will support your stances when
  discussing policy. We'll provide talking points, so you're
  prepared.
- Be respectful of time: Members have tight schedules.
  Keep things focused and on time. You will want to make
  sure that you are familiar with the agenda for the visit and
  how long each portion of the visit will approximately take
  (greeting the Member of Congress, facility tour, policy
  discussion, etc.).
- Talk about YOU: Share your experiences as a professional in your field and as a constituent. Personal stories make the biggest impact.
- **Follow up:** Send a thank-you note and recap key points from the visit.
- Submit feedback: Tell TWC staff what happened and what follow-up may be needed. This will help the TWC when crafting legislative strategy for the remainder of the year.

### **Scheduling a Meeting**

If you're ready to have a meeting with any of your legislators, visit the <u>TWC In-District Meeting Signup</u> <u>Page</u>, and TWC staff will follow-up with you to help set up your meeting.

The following insights can help lay the groundwork for a successful meeting and help cultivate a stronger relationship with your elected official:

- Be flexible: Meetings may be rescheduled or moved. Roll with it!
- Be prepared: Know the issues and bring materials. TWC staff will supply talking points.
- Make the ask: Be direct and confident about what you'd like your Member of Congress to do (support the Freedom to Invest in Tomorrow's Workforce Act).
- Don't stress if you don't know something: It's okay to follow up later. We'll help.
- Share your story: How does this issue affect you, your stakeholders, or your broader organization?
- Follow up and report back: Feedback helps us track progress and plan accordingly for additional legislative pushes.
